Introduction

Internal Revenue Code (IRC) Section 501(r) requires health care organizations to assess the health needs of their communities and adopt implementation strategies to address identified needs. Per IRC Section 501(r), a byproduct of the *Affordable Care Act*, to comply with federal tax-exemption requirements, a tax-exempt hospital facility must:

- ✓ Conduct a community health needs assessment (CHNA) every three years.
- ✓ Adopt an implementation strategy to meet the community health needs identified through the assessment.
- ✓ Report how it is addressing the needs identified in the CHNA as well as a description of needs that are not being addressed with the reasons why such needs are not being addressed.

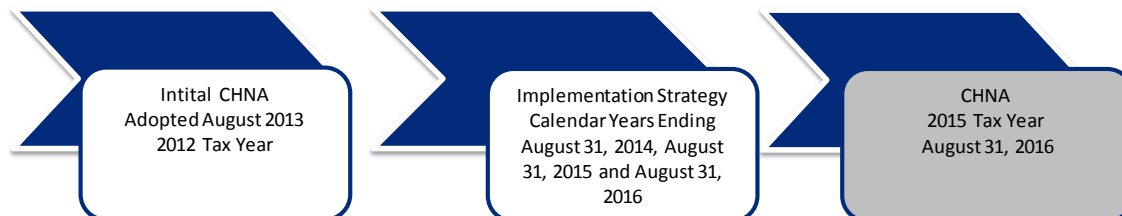
The CHNA must take into account input from persons including those with special knowledge of or expertise in public health, those who serve or interact with vulnerable populations and those who represent the broad interest of the community served by the hospital facility. The hospital facility must make the CHNA widely available to the public.

This CHNA, which describes both a process and a document, is intended to document Hendrick Medical Center's (Medical Center or Hendrick) compliance with IRC Section 501(r)(3). Health needs of the community have been identified and prioritized so that the Medical Center may adopt an implementation strategy to address specific needs of the community.

The *process* involved:

- ✓ An evaluation of the implementation strategy for fiscal years ending August 31, 2014 through August 31, 2016, which was adopted by the Medical Center board of directors in 2013.
- ✓ Collection and analysis of a large range of data, including demographic, socioeconomic and health statistics, health care resources and hospital data.
- ✓ Obtaining community input through interviews with key stakeholders who represent a) persons with specialized knowledge in public health, b) populations of need or c) broad interests of the community.

This *document* is a summary of all the available evidence collected during the CHNA conducted in tax year 2015. It will serve as a compliance document, as well as a resource, until the next assessment cycle. Both the *process* and *document* serve as the basis for prioritizing the community's health needs and will aid in planning to meet those needs.



Summary of Community Health Needs Assessment

The purpose of the CHNA is to understand the unique health needs of the community served by the Medical Center and to document compliance with new federal laws outlined above.

The Medical Center engaged **BKD, LLP** to conduct a formal CHNA. **BKD, LLP** is one of the largest CPA and advisory firms in the United States, with approximately 2,000 partners and employees in 34 offices. BKD serves more than 900 hospitals and health care systems across the country. The CHNA was conducted from January 2016 to June 2016.

Based on current literature and other guidance from the treasury and the IRS, the following steps were conducted as part of Hendrick's CHNA:

- An evaluation of the impact of actions taken to address the significant health needs identified in the tax year 2013 CHNA was completed to understand the effectiveness of the Hendrick's current strategies and programs.
- The "community" served by Hendrick was defined by utilizing inpatient data regarding patient origin. This process is further described in *Community Served by the Medical Center*.
- Population demographics and socioeconomic characteristics of the community were gathered and reported utilizing various third parties (see references in *Appendices*). The health status of the community was then reviewed. Information on the leading causes of death and morbidity information was analyzed in conjunction with health outcomes and factors reported for the community by the Center for Disease Control and Prevention (Community Health Status Indicators) as well as countyhealthrankings.org. Health factors with significant opportunity for improvement were noted.
- Community input was provided through key stakeholder interviews of 33 stakeholders. Results and findings are described in the *Key Stakeholder Interview Results* section of this report.
- Information gathered in the above steps was analyzed and reviewed to identify health issues of uninsured persons, low-income persons and minority groups and the community as a whole. Health needs were ranked utilizing a weighting method that weighs 1) the size of the problem, 2) the seriousness of the problem, 3) the impact of the issues on vulnerable populations, 4) the prevalence of common themes and 5) how important the issue is to the community.
- An inventory of health care facilities and other community resources potentially available to address the significant health needs identified through the CHNA was prepared and collaborative efforts were identified.

Health needs were then prioritized taking into account the perceived degree of influence the Medical Center has to impact the need and the health needs impact on overall health for the community. Information gaps identified during the prioritization process have been reported.

General Description of the Medical Center

Hendrick Medical Center is a 522 bed medical center located in Abilene, Texas, that offers a women's center, cancer center and numerous other innovative services. In service for over 90 years, Hendrick was the first hospital to permanently serve the Texas Midwest when its doors opened in 1924. Hendrick is an institution where people can feel a strong sense of belonging, an advanced medical provider the people of Texas Midwest can call their own.

Hendrick offers aggressive, innovative treatments and preventative healthcare measures ranging from services such as cancer screenings and pre-natal education courses to electro-physiology procedures and pediatric intensive care. Providing the strength of a complete system of health services available in their own backyards, most of the citizens of Abilene and the 19 counties that surround it look to Hendrick as their first choice for healthcare. In fact, research shows 64 percent of area residents prefer Hendrick for their healthcare needs.

Evaluation of Prior Implementation Strategy

The implementation strategy for fiscal years ending August 30, 2014 – August 30, 2016, focused on three priorities to address identified health needs. Based on the Medical Center's most recent evaluation, the Medical Center has made significant progress in meeting their goals and strategies outlined in their 2013 Implementation Strategy as reported below.

Summary of 3-year Results – 2013 Implementation Strategy

Priority 1: Primary Care Physicians

- ✓ Added 2 Internal Medicine providers (Net 1)
- ✓ Added 4 Family Medicine providers (Net 3)
- ✓ Opening of South Abilene, Hendrick Medical Plaza
- ✓ Continued partnership with Presbyterian Medical Care Mission to care for uninsured patients
- ✓ Rural response to health needs in surrounding areas

Priority 2: Health Education

- ✓ In 3 years, documented approximately 17,797 education opportunities (Cancer, Heart, COPD, Diabetes, Ortho, Wellness & Women's Health)
- ✓ 1,027 screened at A Day to Take Heart
- ✓ 2,425 received diabetes education
- ✓ Increased Joint Venture attendance from 92% to 95%
- ✓ Health education partnership with IRC to target refugee health

Priority 3: Chronic Disease Management

- ✓ Diabetes education working with Stephens Memorial Hospital to trial a satellite DSME Clinic in Breckenridge one day a month as of March 2016.
- ✓ Heart Failure Accreditation achieved and Transition of Care program implemented
- ✓ Pathways program expanded to include outpatient services
- ✓ 300 enrolled in Hendrick Professional Pharmacy program to assist chronic disease patients acquire medications as low as \$2 per prescription.
 - CHF, DM, COPD and HTN for \$2.00 per month per prescription if the patient has a financial barrier defined as medical insurance that provides no coverage of these items.
- ✓ Collaboratively with Texas Tech University Health Sciences Center (TTUHSC), a Federally Qualified Health Center (FQHC) was established.
- ✓ Texas Tech FQHC provides indigent, uninsured and underserved healthcare by nurse practitioners and collaborates with HMC chronic care program in the management of these patients

Summary of Findings – 2015 Tax Year CHNA

Health needs were identified based on information gathered and analyzed through the 2016 CHNA conducted by the Medical Center. These identified community health needs are discussed in greater detail later in this report and the prioritized listing is available at *Exhibit 26*.

Based on the prioritization process, the following significant needs were identified:

- Lack of health knowledge/education
- Healthy behaviors/lifestyle choices
- Adult obesity
- Lack of primary care physicians
- High cost of health care
- Uninsured
- Poverty/children in poverty
- Diabetes
- Physical inactivity
- Lack of mental health services/providers
- Language/cultural mindset
- Lack of agency collaboration
- Utilization of emergency room for episodic care
- Heart disease
- Transportation in rural areas

These needs have been prioritized based on information gathered through the CHNA and the prioritization process is discussed in greater detail later in this report.

Community Served by the Medical Center

The Medical Center is located in Abilene, Texas, in Taylor County, 2 hours between Midland and Fort Worth, Texas. The Medical Center is located off Interstate highway 20. As a regional facility, the Medical Center serves residents in and around the Abilene.

Hendrick serves 19 counties that surround Taylor County including Fisher, Jones, Shackelford, Nolan, Callahan, Coke, Runnels and Coleman Counties which surround Taylor County. These counties are more rural in nature and hospitals available in the surrounding counties are primarily critical access hospitals. Some of the surrounding counties do not have a hospital located within them.

Defined Community

A community is defined as the geographic area from which a significant number of the patients utilizing Medical Center services reside. While the CHNA considers other types of health care providers, the Medical Center is the single largest provider of acute care services. For this reason, the utilization of Medical Center services provides the clearest definition of the community.

Based on the patient origin of acute care inpatient discharges from July 1, 2014, through August 31, 2015, management has identified Taylor County as the defined CHNA community. Taylor County represents approximately 60% of the inpatient discharges as reflected in *Exhibit 1* below. The CHNA will utilize data and input from this county, as well as the top five zip codes within Taylor County to analyze health needs for the community.

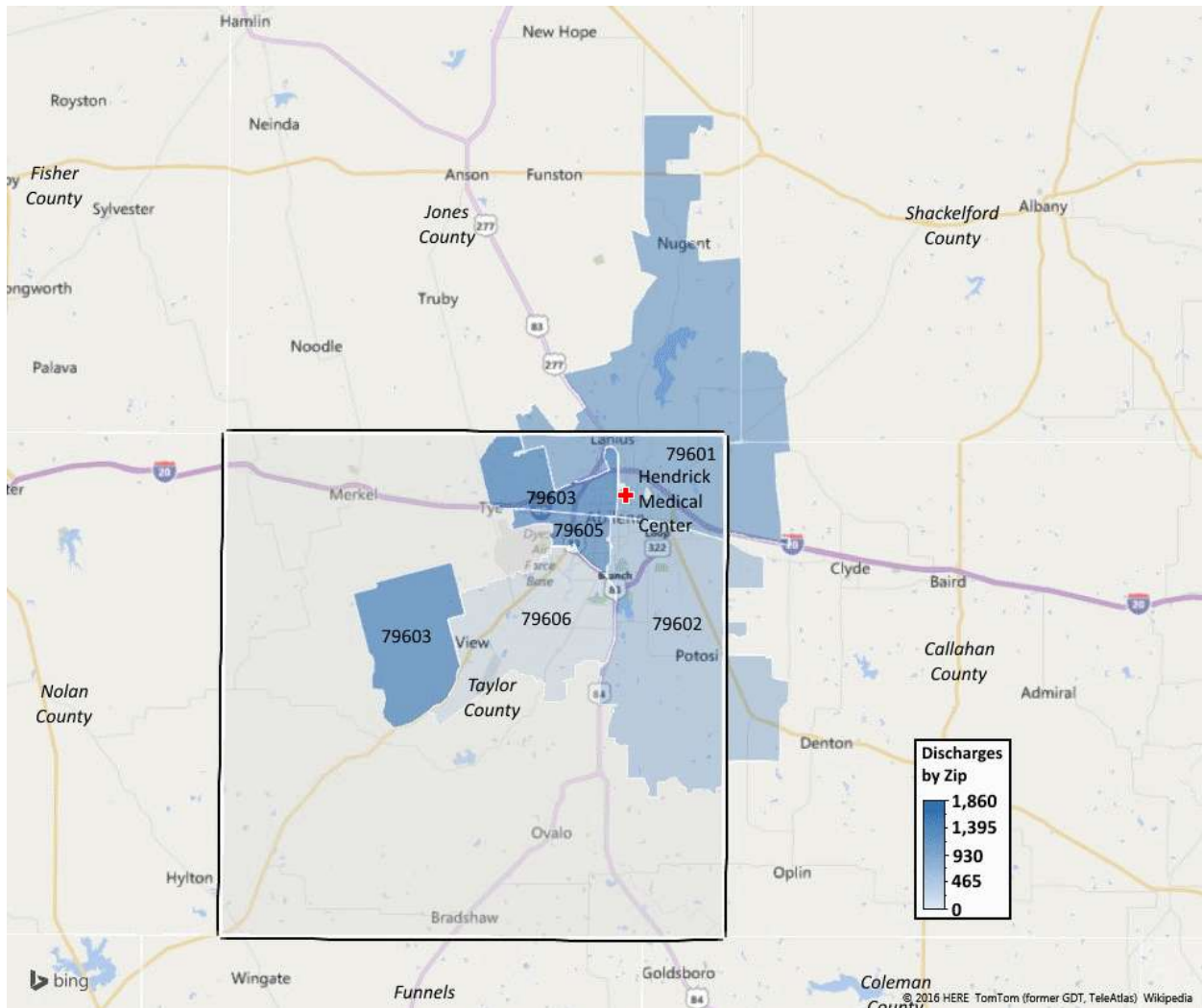

While the relative age of the community population can impact community health needs, so can the ethnicity and race of a population. The population of the CHNA community by race and illustrates different categories of race such as, white, black, Asian, other and multiple races. White non-Hispanics make up almost 66% of the community while Hispanics make up approximately 23% of the CHNA community. The community within Taylor County is more diverse when comparing all other race/ethnicities to the state of Texas. This is largely due to the International Rescue Committee office and services available in Abilene (Taylor County), which provides opportunities for refugees to thrive in America.

Exhibit 3 reports the percentage of population living in urban and rural areas. Urban areas are identified using population density, count, and size thresholds. Urban areas also include territory with a high degree of impervious surface (development). Rural areas are all areas that are not urban. This table could help to understand why transportation may or may not be considered a need within the community, especially within the rural and outlying populations.

Socioeconomic Characteristics of the Community

The socioeconomic characteristics of a geographic area influence the way residents access health care services and perceive the need for health care services within society. The economic status of an area may be assessed by examining multiple variables within the CHNA community. The following exhibits are a compilation of data that includes household per capita income, unemployment rates, poverty, uninsured population and educational attainment for the CHNA community. These standard measures will be used to compare the socioeconomic status of the community to the state of Texas and the United States.

Income and Employment

Exhibit 4 presents the per capita income for the CHNA community. This includes all reported income from wages and salaries, as well as income from self-employment, interest or dividends, public assistance, retirement and other sources. The per capita income in this exhibit is the average (mean) income computed for every man, woman and child in the specified area. Taylor County’s per capita income is below the state of Texas and the United States. There is a large disparity between zip codes 79601 and 79606 within the CHNA community; with 79601 having a per capita income well below Texas and the United States.

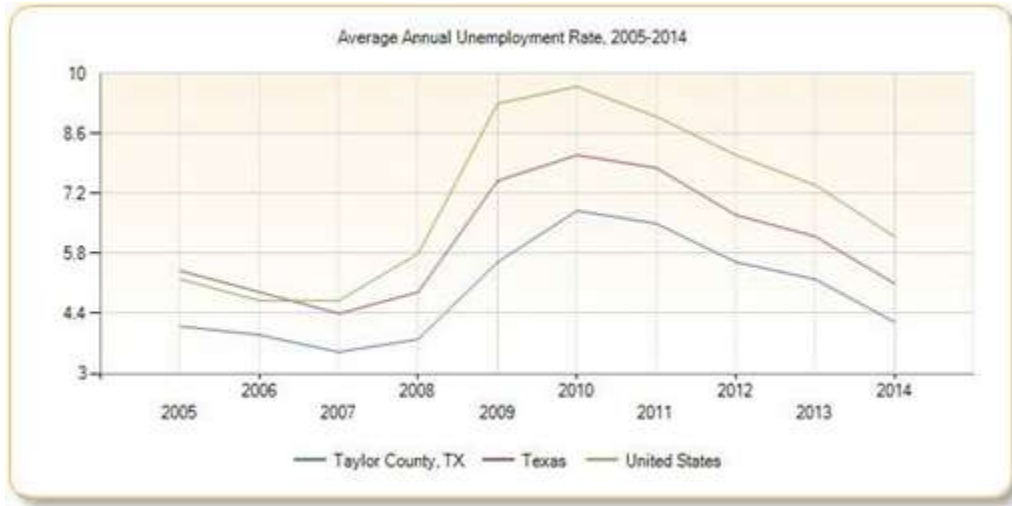

Unemployment Rate

Exhibit 5 presents the average annual unemployment rate from 2005 - 2014 for the community defined as the community, as well as the trend for Texas and the United States. On average, the unemployment rates for the community are lower than both the United States and the state of Texas. A decrease in the unemployment rate has been the trend since 2010.

Poverty

Exhibit 6 presents the percentage of total population below 100% Federal Poverty Level (FPL). Poverty is a key driver of health status and is relevant because poverty creates barriers to access, including health services, healthy food choices and other factors that contribute to poor health. Taylor County’s poverty rate is greater than the state poverty rate and the national rate. Zip code 79601 has the highest poverty rate of 29.83% when compared to Texas and the United States.

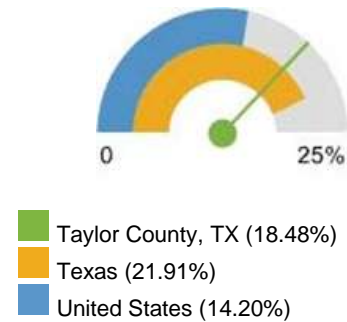
Uninsured

Exhibit 7 reports the percentage of the total civilian non-institutionalized population without health insurance coverage. This indicator is relevant because lack of insurance is a primary barrier to health care access, including regular primary care, specialty care and other health services that contribute to poor health status. *Exhibit 7* shows almost 24,000 persons are uninsured in the CHNA community based on 5-year estimates produced by the U.S. Census Bureau, 2010-2014 American Community Survey. However, the 2015 uninsured rate is estimated to be 16% for Taylor County, per www.enrollamerica.org, which indicates the uninsured population has decreased by an additional 2,000 persons, since 2014, in in the CHNA Community; primarily the result of the Affordable Care Act. The table below shows of the main zip codes, zip code 79603 has the highest percentage of uninsured and is the only zip code higher than Texas and the United States rate.

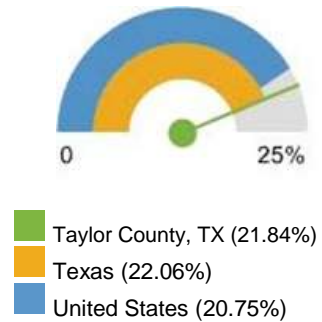
Medicaid

The Medicaid indicator reports the percentage of the population with insurance enrolled in Medicaid (or other means-tested public health insurance). This is relevant because it assesses vulnerable populations, which are more likely to have multiple health access, health status and social support needs; when combined with poverty data, providers can use this measure to identify gaps in eligibility and enrollment. *Exhibit 8* shows Taylor County as a whole ranks favorably compared to the state of Texas, while zip codes 79603 and 79605 rank unfavorably to both the state of Texas and the United States.

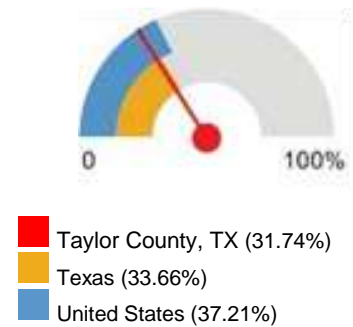

Education levels obtained by community residents may impact the local economy. Higher levels of education generally lead to higher wages, less unemployment and job stability. These factors may indirectly influence community health. As noted in Exhibit 9, the percent of residents within the CHNA community of Taylor County obtaining an associate’s degree or higher is below the state and national percentages. Only zip codes 79602 and 79606 have a greater percentage of the population with an associate’s degree or higher.

Physical Environment of the Community

A community’s health is also affected by the physical environment. A safe, clean environment that provides access to healthy food and recreational opportunities is important to maintaining and improving community health. This section will touch on a few of the elements that relate to some needs mentioned throughout the report.

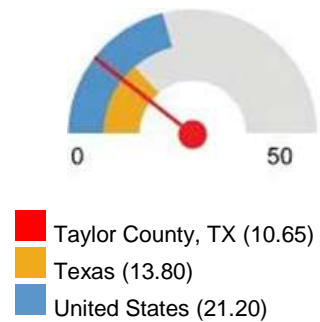
Grocery Store Access

Exhibit 10 reports the number of grocery stores per 100,000-population. Grocery stores are defined as supermarkets and smaller grocery stores primarily engaged in retailing a general line of food, such as canned and frozen foods, fresh fruits and vegetables and fresh and prepared meats, such as fish and poultry. Included are delicatessen-type establishments. Convenience stores and large general merchandise stores that also retail food, such as supercenters and warehouse club stores, are excluded. This indicator is relevant because it provides a measure of healthy food access and environmental influences on dietary behaviors.

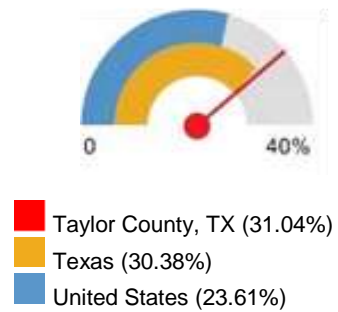
Food Access/Food Deserts

This indicator reports the percentage of the population living in census tracts designated as food deserts. A food desert is defined as a low-income census tract where a substantial number or share of residents has low access to a supermarket or large grocery stores. The information in *Exhibit 11* below is relevant because it highlights populations and geographies facing food insecurity. Taylor County as a whole along with zip codes 79605, 79602, and 79606 have a population with low food access when compared to Texas and the United States.

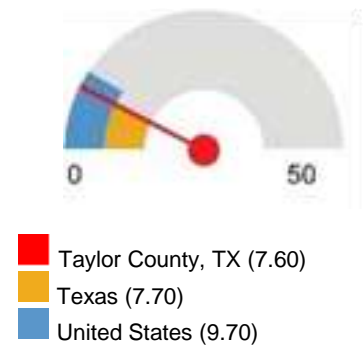
Recreation and Fitness Facility Access

This indicator reports the number per 100,000-population of recreation and fitness facilities as defined by North American Industry Classification System (NAICS) Code 713940. It is relevant because access to recreation and fitness facilities encourages physical activity and other healthy behaviors. *Exhibit 12* shows that Taylor County has fewer fitness establishments available to the residents of the community than Texas as a whole.

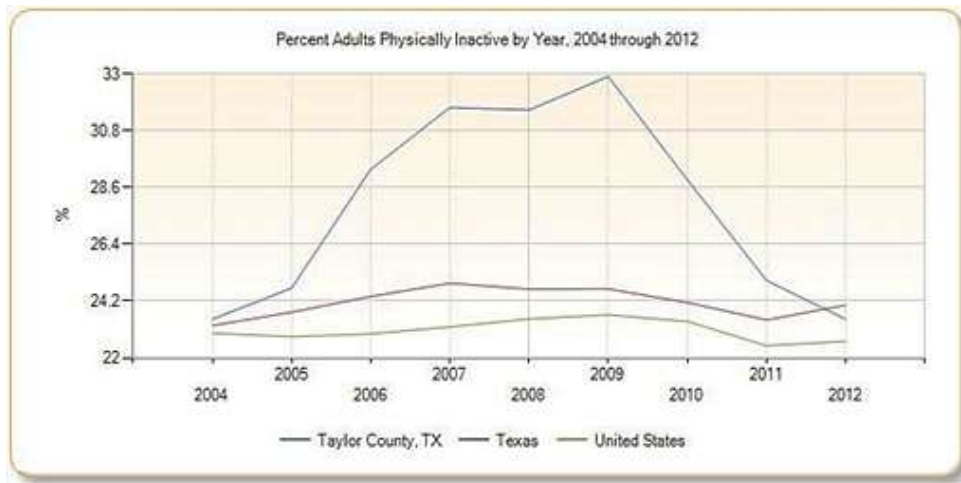
Recreation and Fitness Facilities, Rate (Per 100,000 Population)

The trend graph below (*Exhibit 13*) shows the percentage of adults who are physically inactive by year for the community and compared to Texas and the United States. From 2005-2009, the CHNA community percentage of adults who are physically inactive were on the rise and higher than both the state of Texas and the United States. The trend has been decreasing since 2009, when the community hit a peak of 33%. The latest data (2012) shows that the community now has a lower percentage of physically inactive adults than the state of Texas.

Clinical Care of the Community

A lack of access to care presents barriers to good health. The supply and accessibility of facilities and physicians, the rate of uninsured, financial hardship, transportation barriers, cultural competency and coverage limitations affect access.

Rates of morbidity, mortality and emergency hospitalizations can be reduced if community residents access services such as health screenings, routine tests and vaccinations. Prevention indicators can call attention to a lack of access or knowledge regarding one or more health issues and can inform program interventions.

Access to Primary Care

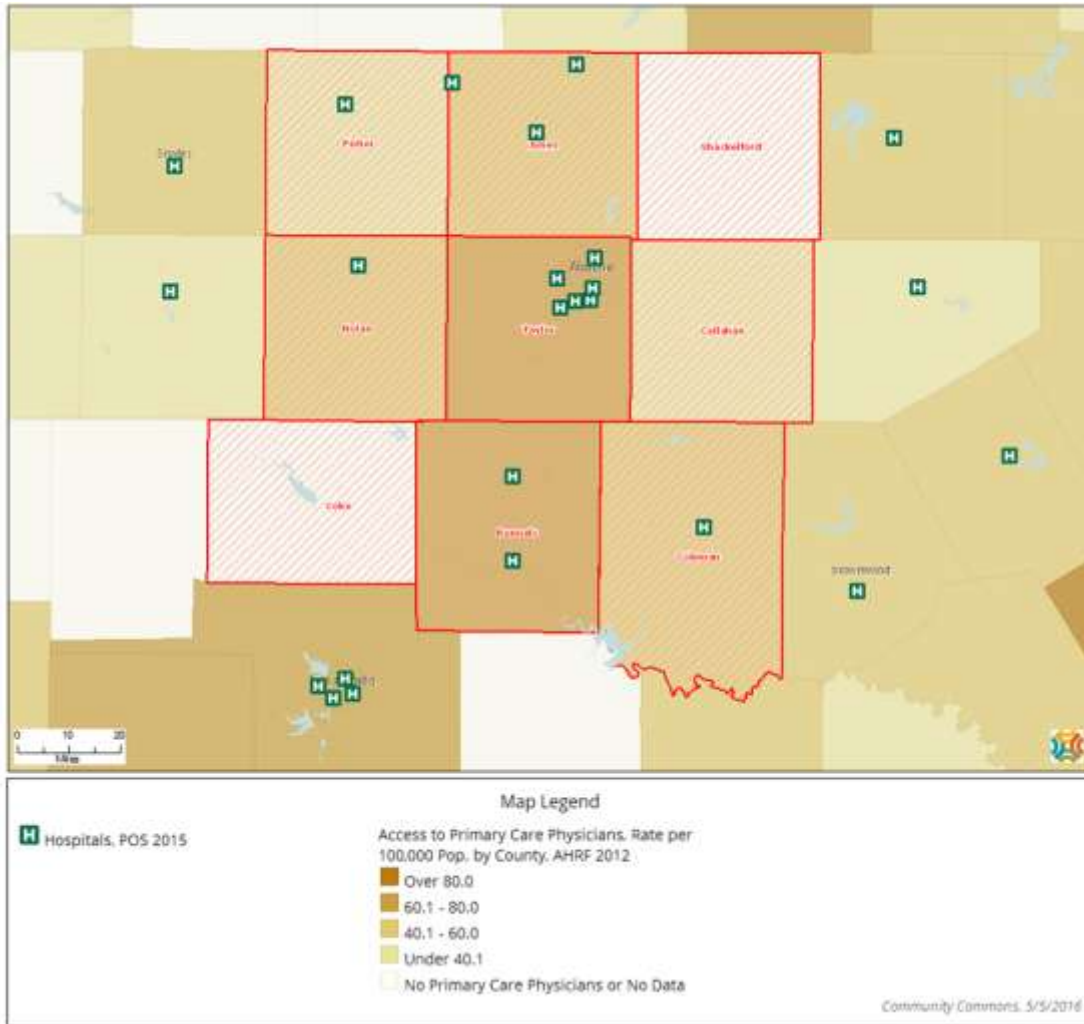
Exhibit 14 shows the number of primary care physicians per 100,000-population. Doctors classified as “primary care physicians” by the American Medical Association include general family medicine MDs and DOs, general practice MDs and DOs, general internal medicine MDs and general pediatrics MDs. Physicians age 75 and over and physicians practicing sub-specialties within the listed specialties are excluded. This indicator is relevant because a shortage of health professionals contributes to access and health status issues.

Although the above Exhibit shows Taylor County as having a greater rate of primary care physicians than the state, the map below shows many of the surrounding counties are lacking sufficient access to primary care. Many of the hospitals located in these counties are short-term and critical access hospitals, while some counties do not even have a hospital located within them (for example, Coke and Shackelford Counties). Residents in the surrounding counties rely on medical providers located in Taylor County. The rate of primary care physicians per 100,000 population for the counties outlined in red on the map below is 53.4 which is below the state and national rates.



Lack of a Consistent Source of Primary Care

Exhibit 15 reports the percentage of adults aged 18 and older who self-report that they do not have at least one person who they think of as their personal doctor or health care provider. This indicator is relevant because access to regular primary care is important to preventing major health issues and emergency department visits.

Population Living in a Health Professional Shortage Area

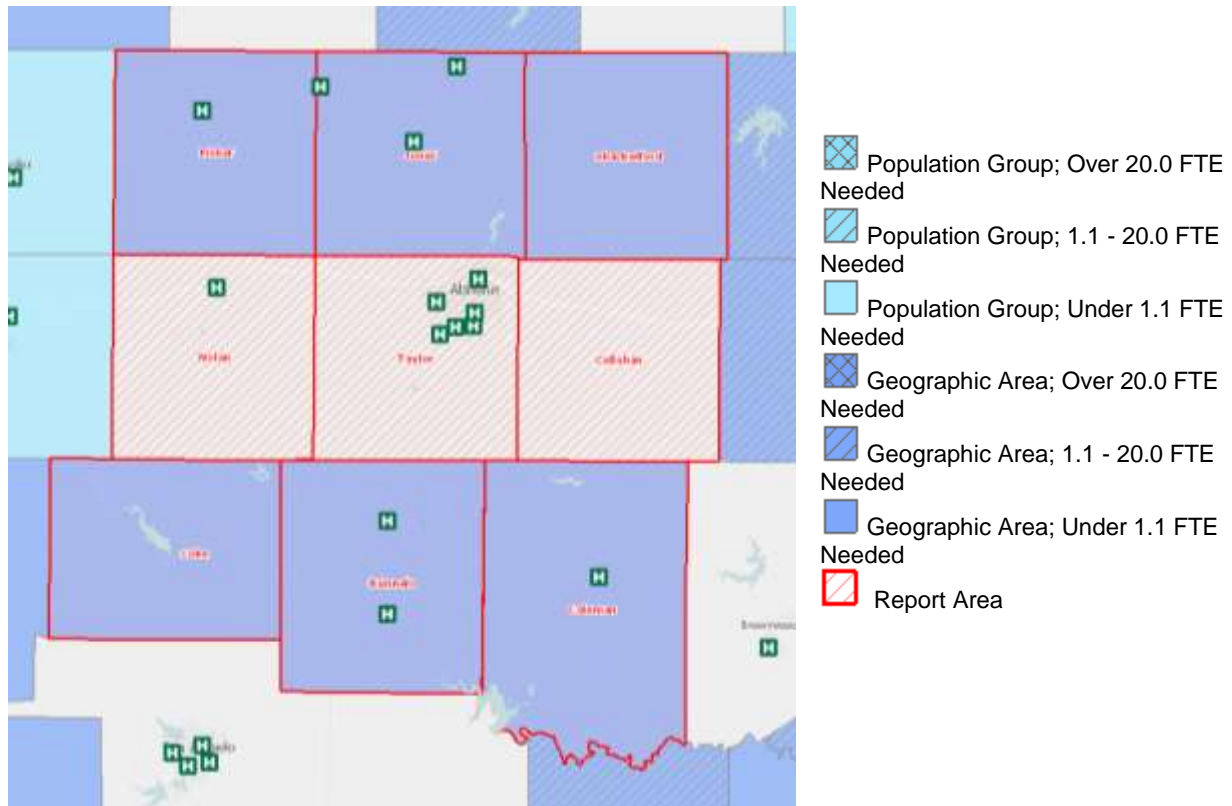

This indicator is relevant because a shortage of health professionals contributes to access and health status issues. As *Exhibit 16* below shows, Taylor County is not considered a health professional shortage area. The map below show residents within all the surrounding counties are living in a health professional shortage area, with the exception of Nolan and Callahan Counties.

Preventable Hospital Events

Exhibit 17 reports the discharge rate (per 1,000 Medicare enrollees) for conditions that are ambulatory care sensitive (ACS). ACS conditions include pneumonia, dehydration, asthma, diabetes and other conditions, which could have been prevented if adequate primary care resources were available and accessed by those patients. This indicator is relevant because analysis of ACS discharges allows demonstrating a possible “return on investment” from interventions that reduce admissions (for example, for uninsured or Medicaid patients) through better access to primary care resources.

Health Status of the Community

This section of the assessment reviews the health status of the CHNA community and its residents. As in the previous section, comparisons are provided with the state of Texas and the United States. This in-depth assessment of the mortality and morbidity data, health outcomes, health factors and mental health indicators of the county residents that make up the CHNA community will enable the Medical Center to identify priority health issues related to the health status of its residents.

Good health can be defined as a state of physical, mental and social well-being, rather than the absence of disease or infirmity. According to *Healthy People 2020*, the national health objectives released by the U.S. Department of Health and Human Services, individual health is closely linked to community health. Community health, which includes both the physical and social environment in which individuals live, work and play, is profoundly affected by the collective behaviors, attitudes and beliefs of everyone who lives in the community. Healthy people are among a community’s most essential resources.

Numerous factors have a significant impact on an individual’s health status: lifestyle and behavior, human biology, environmental and socioeconomic conditions, as well as access to adequate and appropriate health care and medical services.

Studies by the American Society of Internal Medicine conclude that up to 70% of an individual’s health status is directly attributable to personal lifestyle decisions and attitudes. Persons who do not smoke, drink in moderation (if at all), use automobile seat belts (car seats for infants and small children), maintain a nutritious low-fat, high-fiber diet, reduce excess stress in daily living and exercise regularly have a significantly greater potential of avoiding debilitating diseases, infirmities and premature death.

The interrelationship among lifestyle/behavior, personal health attitude and poor health status is gaining recognition and acceptance by both the general public and health care providers. Some examples of lifestyle/behavior and related health care problems include the following:

Health problems should be examined in terms of morbidity as well as mortality. Morbidity is defined as the incidence of illness or injury, and mortality is defined as the incidence of death. Such information provides useful indicators of health status trends and permits an assessment of the impact of changes in health services on a resident population during an established period of time. Community attention and health care resources may then be directed to those areas of greatest impact and concern.

Leading Causes of Death and Health Outcomes

Exhibit 18 reflects the leading causes of death for the community and compares the age-adjusted rates to the state of Texas and the United States.

The table above shows leading causes of death within Taylor County as compared to the state of Texas and the United States. The age-adjusted rate is shown per 100,000 residents. The rates in red represent Taylor County and corresponding leading causes of death that are greater than the state rates. As the table indicates, all of the leading causes of death above are greater than the Texas and national rates.

Health Outcomes and Factors

An analysis of various health outcomes and factors for a particular community can, if improved, help make the community a healthier place to live, learn, work and play. A better understanding of the factors that affect the health of the community will assist with how to improve the community’s habits, culture and environment. This portion of the community health needs assessment utilizes information from County Health Rankings, a key component of the Mobilizing Action Toward Community Health (MATCH) project, a collaboration between the Robert Wood Johnson Foundation and the University of Wisconsin Population Health Institute.

The County Health Rankings model is grounded in the belief that programs and policies implemented at the local, state and federal levels have an impact on the variety of factors that, in turn, determine the health outcomes for communities across the nation. The model provides a ranking method that ranks all 50 states and the counties within each state, based on the measurement of two types of health outcomes for each county: how long people live (mortality) and how healthy people feel (morbidity). These outcomes are the result of a collection of health factors and are influenced by programs and policies at the local, state and federal levels.

Counties in each of the 50 states are ranked according to summaries of a variety of health measures. Those having high ranks, e.g. 1 or 2, are considered to be the “healthiest”. Counties are ranked relative to the health of other counties in the same state based on health outcomes and factors, clinical care, economic status and the physical environment.

A number of different health factors shape a community’s health outcomes. The County Health Rankings model includes four types of health factors: health behaviors, clinical care, social and economic and the physical environment. As can be seen from the chart below, all rankings within each area have improved from 2012 with the exception of physical environment.

Community Health Status Indicators

The Community Health Status Indicators (CHSI) Project of the U.S. Department of Health and Human Services compares many health status and access indicators to both the median rates in the United States and to rates in “peer counties” across the United States. Counties are considered “peers” if they share common characteristics such as population size, poverty rate, average age, and population density.

Taylor County has multiple designated “peer” counties throughout the US, including Tom Green, Wichita and Victoria Counties in Texas, Pueblo County in Colorado and Comanche County in Oklahoma. *Exhibit 20* provides a summary comparison of how Taylor County compares with peer counties on the full set of primary indicators. Peer county values for each indicator were ranked and then divided into quartiles.

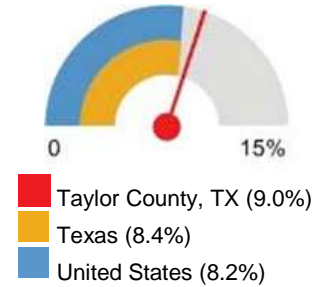

Community Input – Key Stakeholder Interviews

Interviewing key stakeholders (persons with knowledge of or expertise in public health, community members who represent the broad interest of the community or persons representing vulnerable populations) is a technique employed to assess public perceptions of the county's health status and unmet needs. These interviews are intended to ascertain opinions among individuals likely to be knowledgeable about the community and influential over the opinions of others about health concerns in the community.

Methodology

Interviews were performed with 33 key stakeholders. Stakeholders were determined based on a) their specialized knowledge or expertise in public health, b) their involvement with underserved and minority populations or c) their affiliation with local government, schools and industry.

All interviews were conducted by BKD personnel. Participants provided comments on the following issues:

- ✓ Health and quality of life for residents of the primary community
- ✓ Underserved populations and communities of need
- ✓ Barriers to improving health and quality of life for residents of the community
- ✓ Opinions regarding the important health issues that affect community residents and the types of services that are important for addressing these issues

Interview data was initially recorded in narrative form asking participants a series of fourteen questions. Please refer to *Appendix D* for a copy of the interview instrument. This technique does not provide a quantitative analysis of the stakeholders' opinions but reveals community input for some of the factors affecting the views and sentiments about overall health and quality of life within the community.

Key Stakeholder Profiles

Key stakeholders from the community (see *Appendix D* for a list of key stakeholders) worked for the following types of organizations and agencies:

- ✓ Hendrick Medical Center
- ✓ Social service agencies and non-profit organizations
- ✓ Local school systems and universities
- ✓ Public health agencies
- ✓ Other medical providers
- ✓ Local elected officials and governmental agencies
- ✓ Local businesses

Key Stakeholder Interview Results

The questions on the interview instrument are grouped into four major categories for discussion. The interview questions for each key stakeholder were identical. A summary of the stakeholders' responses by each of the categories follows. Paraphrased quotes are included to reflect some commonly held opinions and direct quotes are employed to emphasize strong feelings associated with the statements.

This section of the report summarizes what the key stakeholders said without assessing the credibility of their comments.

1. General Opinions Regarding Health and Quality of Life in the Community

The key stakeholders were asked to rate the health and quality of life in Taylor County. They were also asked to provide their opinion whether the health and quality of life had improved, declined or stayed the same over the past few years. Lastly, key stakeholders were asked to provide support for their answers.

Forty-two percent (14 out of 33) rated the health and quality of life as “above average” or “very good”. Fifty-four percent (18 out of 33) of the key stakeholders rated the health and quality of life in their county as “good”, “average” or “fair”. Only one key stakeholder rated the health and quality of life as “less than average” or “poor”. Stakeholders noted that for a community the size of the Abilene there are good health resources available to the community. They referred to the recent opening of more clinics by medical providers and the city having a positive impact to the community. Stakeholders also thought there has been increased focus on health promotion and the community is being encouraged to be more physically active. The community has a significant number of nonprofit organizations serving the community and stakeholders acknowledged the philanthropic culture within Taylor County to be a community asset. Many organizations are partnering together and coordinating services to avoid duplication and combine resources to address unmet needs.

Conditions such as obesity, diabetes and high blood pressure were mentioned most often as negatively impacting the health of the community. Additionally, the challenges that come with having a significant refugee population, as a result of the International Rescue Committee, were mentioned as impacting health and quality of life in the community. Significant resources are required to assimilate refugees into the community, including integration into the healthcare system.

When asked whether the health and quality of life had improved, declined or stayed the same, almost half of the stakeholders, 15 of 33, responded they felt the health and quality of life had improved over the last few years. Fourteen of the remaining 33 stakeholders expressed they thought the health and quality of life had stayed the same over the last three years. When asked why they thought the health and quality of life had improved, key stakeholders noted the Abilene Community Health Center, a Federally Qualified Health Center opened by Texas Tech School of Nursing in the fall of 2015, had made a significant positive impact on the availability of services to low-income and uninsured members of the community. They also highlighted the increased contribution of Hendrick Medical Center to the Medical Mission. Stakeholders feelings regarding health reform were mixed, but many stakeholders acknowledged the increase in the insured population as a result of the Affordable Care Act.

Other positive factors include services provided by the health department including recently expanded women’s services as well as efforts of recruiting more primary care physicians to the community and the increased expansion of the Texas Tech Health Sciences Center. The addition of more hospitalists to the physician group is providing increased access for patients, post-discharge from the hospital.

Even though there have clearly been efforts at expanding access to primary care, stakeholders consistently mentioned that persons in the community improperly utilize the hospital’s emergency room and continued efforts are needed to educate the community on the available resources for care; particularly for low-income and uninsured persons.

“There are a lot of smart people here and they are interested in the community doing well.”

“The health department has made strides to expand health services.”

“Education is not changing people’s behaviors to go to the doctor and prevention is not reaching the people to keep them out of the emergency room.”

“Hendrick Medical Center is bringing more health professionals to the community.”

2. Underserved Populations and Communities of Need

Key stakeholders were asked to provide their opinions regarding specific populations or groups of people whose health or quality of life may not be as good as others. BKD also asked the key stakeholders to provide their opinions as to why they thought these populations were underserved or in need. Each key stakeholder was asked to consider the specific populations they serve or those with which they usually work.

Virtually, all of the key stakeholders identified persons living with low-incomes or in poverty as most likely to be underserved due to lack of access to services. Lack of financial resources prevents persons with low-income from seeking medical care and receiving the resources they need. It also leads to people being uninsured and underinsured. Stakeholders noted that knowing how to effectively utilize insurance programs such as Medicaid and/or Children’s Health Insurance Plan (CHIP) is an issue. For these families, access to care is available, but they simply do not understand where to go or how to navigate the health system. Often, persons living with low-income also have less access to reliable transportation.

Persons with mental health needs were also identified as a population whose health needs are not being met in the community. Stakeholders expressed a lack of mental health providers resulting in long waits for appointments. Additionally, the stigma surrounding mental illness prevents people from getting help. The stigma also causes people to stop taking medicines for behavioral health conditions. Mental health patients are complicated to serve and often chronic health conditions accompany mental health issues. For these patients, there is a need for more coordinated care.

The poor elderly were also identified as a population that is faced with challenges accessing care due to limited transportation and fixed incomes. Poor elderly who do not have adequate support systems have a difficult time managing chronic diseases without additional support and they are often not equipped to take care of themselves when they are released from an inpatient stay at the hospital.

The refugee population and other immigrant populations were regularly noted as persons who may have unmet health needs due to language barriers, cultural differences that make them reluctant of care and fear of repercussions of being caught, for those who are in the United States illegally. Stakeholders noted that interpretation services offered by Hendrick make a big difference in the ability to provide medical care and outreach to the non-English speaking population, but most providers don’t have interpretation services which is a barrier.

The homeless population has few resources for healthcare, transportation, housing and food. There are some church missions who serve this population, but resources are limited.

Key stakeholders were then asked to provide opinions regarding actions that should be taken to respond to the identified needs above. Many of the stakeholders suggested that free screenings should be continued and their availability and frequency should be increased. Some of the stakeholders felt communication regarding free screenings and low-cost services may need to be intentionally directed to the underserved populations who need these services most and some stated they thought many persons in the community are still unaware of these services. They also felt that

screenings and health education events should be conducted out in neighborhood settings and where people who need the services most already are instead of in the hospital.

Stakeholders also suggested that organizations should focus on common issues and programs and that a single convener would be valuable to coordinate services and monitor activities. Due to limited funding, the best way to address certain issues will be for organizations to network and work together.

Finally, stakeholders suggested a task force/intense group be formed to evaluate what can be done regarding mental health services in the community.

“The more we can prevent, the better outcomes we will have.”

“In order to get to the parts of the community that need to be reached, you need to go out into the community.”

“Outreach needs to be done in people’s neighborhoods. Integrate health education with what is already happening in the neighborhoods.”

“We all need to work together (health department, Texas Tech, Community Health Center and hospitals) to get prevention and healthy living out there.”

3. Barriers

The key stakeholders were asked what barriers or problems keep community residents from obtaining necessary health services and improving health in their community. The majority of the key stakeholders indicated lack of financial resources is the biggest barrier to improving health in the community. Stakeholders noted that there are many people in the community who lack insurance due to the high cost. Persons who may be employed need to choose between food, shelter, basic needs and health insurance. Healthcare often costs more than household budgets can pay for. Resources available for persons who are uninsured are limited in the community. The opening of the Abilene Community Health Center is another additional resource for these persons, but efforts need to be made to educate the community on available services. Stakeholders emphasized that people, particularly those that need services most, lack knowledge surrounding available services and they don’t know how to navigate the health system. Additionally, they are uninformed and uneducated on how insurance works.

Stakeholders also noted the culture does not emphasize physical activity even though there have been recent efforts to address this and the community does not see value in preventive care. Smoking and obesity were identified as unhealthy behaviors or conditions prevalent in the community.

Difficulty in accessing primary care physicians was also noted as a barrier to improving health. Stakeholders noted it is a struggle to recruit new physicians to the community. They also stated there are limited providers in the community and many physician offices have limited hours, *i.e.* closed on Fridays and during the lunch hour. In order for physician offices to remain financially viable, physicians are limiting the number of Medicaid and/or Medicare patients they can take as patients. There are even fewer physician resources for uninsured patients.

The lack of communication and collaboration among agencies, organizations and local government was also noted as a barrier. Stakeholders acknowledged there are many organizations providing much needed services in the community. However, many organizations are working in silos. Stakeholders expressed the need for organizations to work together to work to address issues in the community as a whole. They felt more could be accomplished by organizations partnering together

or working together on strategic plans which would also result in the most efficient and cost-effective use of community financial resources.

Transportation was noted as a barrier to health services and stakeholders identified that accessing health services is difficult for some with the current transportation system. They also shared that persons who would like to utilize the Medical Mission or Community Health Center may not have a way to get there.

“People don’t want to make the necessary life choices for better health.”

“People don’t know what resources are available and that if it’s a minor health issue, they should call their primary care physician.”

“Healthcare is expensive-whether you are insured or not. You have to make that investment.”

“Even though people are working, their income isn’t as high. When people are working, they have to decide whether to pay electric bill or groceries instead of healthcare.”

“It is really hard to get collaboration between local government, businesses and nonprofit organizations. All of these groups are trying to address the issues in silos, but we need to look at the community as a whole.”

4. Most Important Health and Quality of Life Issues

Key stakeholders were asked to provide their opinion as to the most critical health and quality of life issues facing the county. The issues identified most frequently were:

- Obesity
- Lack of primary care for Medicaid and Medicare patients
- The increased need for mental health services due to increased drug and alcohol abuse as well as the lack of mental health providers in the community.

It was also noted that diabetes, cancer and heart disease are health conditions that impact the community.

The aging population and the growing number of patients with dementia or Alzheimer’s were noted as an emerging issue in the community. As the older population continues to age, additional services will be needed to care for them and coordination of care will become more important.

Education of the community’s children was also a concern for stakeholders. Stakeholders felt that children are not being taught basic life skills and are unprepared to take care of themselves as young adults. A high percentage of children in the community are going up in poverty and educational opportunities are limited. Students are in need of education on a variety of topics such as health, nutrition and financial literacy.

The key stakeholders were also asked to provide suggestions on what should be done to address the most critical issues. Responses included:

- Many of the key stakeholders recommended that education is the best way to address most of the needs identified above. Education on preventive care, healthy living and awareness regarding available resources targeted to the populations who most need is recommended. Stakeholders recommended partnering with schools and youth programs in order to access families in settings where they already are to incorporate health education or related health information. Stakeholders also recommended the Hospital should continue to increase partnerships and collaborations to help in the delivery of educational programs to reduce costs and expand outreach
- Educational activities, health fairs and screening events should be coordinated and conducted with programs which are already occurring out in the community.
- Strategic priorities should be identified and communicated to the community and organizations should work together to focus on common issues.
- Consistent and routine communication regarding community resources and changes to available resources is needed. 211 is great for the community, but the organizations serving the community need to be aware of what the other organizations are doing and specifics regarding how they are doing it so they can effectively communicate with persons who need to access the available service. A forum where all groups serving the community could regularly come together to share information and foster collaborative efforts would be beneficial.
- The community should come together to address mental health issues and the shortage of mental health providers in the community.

In closing, the key stakeholders were asked to recommend the most important issue the Hospital should address over the next three to five years. The number one suggestion made by stakeholders was that the Hospital should focus on education and engaging the community in healthy living and preventative care. The Hospital should also promote all of the services and educational opportunities that are available at Hendrick and increase its efforts on engaging the community by conducting events out in the community as opposed to inside the hospital.

Secondly, stakeholders suggested maintaining the focus on recruiting providers to the community, both primary care and specialists, and that Hendrick should consider expanding certain services such as pediatrics and cancer care.

The lack of services available to meet the community's mental health needs was also identified as an important issue the Hospital should address in the next few years.

Stakeholders also suggested increased efforts and focus on transition of care once patients leave the Hospital, noting the importance of follow-up care as well as addressing other concerns that exist in the home environments which inhibits people from getting better or managing chronic diseases such as inability to afford medications, lack of basic necessities and lack of needed assistance or support. Specifically, individuals who incorrectly utilize the Hospital emergency room should be provided additional resources and a care plan.

Key Findings

A summary of themes and key findings provided by the key informants follows:

- The community's perception regarding health and quality of life in Taylor County is very positive and a significant number of key stakeholders felt the health and quality of life in the county was above average.
- The affiliation with Texas Tech is seen very positively by the community.
- Opening of Abilene Community Health Center and expansion of services provided by the Medical Care Mission and the health department are helping serve the low-income and uninsured populations, but there is still a need that exceeds current capacity.
- The community has a number of distinct populations identified as being underserved (low-income, persons with mental health issues, poor elderly, refugees, other immigrants, homeless) which are in need of targeted outreach to address health needs.
- Although most interviewees thought access to care has improved over the past three years, it continues to be an issue due to the shortage of primary care doctors in the community and the cost of health care including co-pays and deductibles associated with high-deductible health plans.
- The community generally has an unhealthy culture due to lack of health knowledge and/or apathy regarding personal health and wellness
- There is a perceived need for increased collaboration among the various organizations serving the community. Organizations need to work together in a more coordinated, strategic approach to respond to community needs.
- The Hospital should seek opportunities to collaborate with other community organizations to help deliver health education to the community and/or aid in communication regarding available educational resources.

Health Issues of Vulnerable Populations

According to Dignity Health's Community Need Index (see *Appendices*), the Medical Center's community has a moderate level of need. The CNI score is an average of five different barrier scores that measure socioeconomic indicators of each community (income, cultural, education, insurance and housing). The median CNI score for Taylor County is 3.6. The zip codes with the highest CNI scores within the community are: 79603 – Abilene (4.8), 79601 – Abilene (4.6), 79605 – Abilene (4.2) and 79602 – Abilene (4.0).

Certain key stakeholders were selected due to their positions working with low-income and uninsured populations. Several key stakeholders were selected due to their work with minority populations. Based on information obtained through key stakeholder interviews and the community health survey, the following populations are considered to be vulnerable or underserved in the community and the identified needs are listed:

- Uninsured/Working Poor Population/Homeless
 - Access to primary care physicians
 - High cost of health care prevents needs from being met
 - Lack of healthy lifestyle and health nutrition education
 - Lack of mental health services
 - Transportation
 - Preventative Care
- Person with Mental Health Needs
 - Lack of mental health providers
 - Substance abuse
- Poor Elderly
 - Cost of prescriptions/health care services
 - Transportation
 - Lack of health knowledge regarding how to navigate and access services
- Refugees/Other Immigrants
 - Lack of health knowledge/culture regarding health
 - Financial barriers
 - Language barriers
 - Access to primary care
 - Fear of repercussions

Information Gaps

This assessment was designed to provide a comprehensive and broad picture of the health in the overall community served by the Medical Center; however, there may be a number of medical conditions that are not specifically addressed in this report due to various factors, including but not limited to, publically available information or limited community input.

In addition, certain population groups might not be identifiable or might not be represented in numbers sufficient for independent analysis. Examples include homeless, institutionalized persons, undocumented residents and members of certain ethnic groups who do not speak English or Spanish. Efforts were made to obtain input from these specific populations through key stakeholder interviews.

Prioritization of Identified Health Needs

Priority setting is a required step in the community benefit planning process. The IRS regulations indicate that the CHNA must provide a prioritized description of the community health needs identified through the CHNA and include a description of the process and criteria used in prioritizing the health needs.

Using findings obtained through the collection of primary and secondary data, the Medical Center completed an analysis of these inputs (see *Appendices*) to identify community health needs. The following data was analyzed to identify health needs for the community:

Leading Causes of Death

Leading causes of death for the community and the death rates for the leading causes of death for each county within the Medical Center's CHNA community were compared to U.S. adjusted death rates. Causes of death in which the county rate compared unfavorably to the U.S. adjusted death rate resulted in a health need for the Medical Center's CHNA community.

Health Outcomes and Factors

An analysis of the County Health Rankings health outcomes and factors data was prepared for each county within Hendrick's CHNA community. County rates and measurements for health behaviors, clinical care, social and economic factors and the physical environment were compared to state benchmarks. County rankings in which the county rate compared unfavorably (by greater than 30% of the national benchmark) resulted in an identified health need.

The indicators falling within the least favorable quartile from the Community Health Status Indicators (CHSI) resulted in an identified health need.

Primary Data

Health needs identified through key informant interviews were included as health needs. Needs for vulnerable populations were separately reported on the analysis in order to facilitate the prioritization process.

Health Needs of Vulnerable Populations

Health needs of vulnerable populations were included for ranking purposes.

To facilitate prioritization of identified health needs, a ranking process was used. Health needs were ranked based on the following five factors. Each factor received a score between 0 and 5.

- 1) **How many people are affected by the issue or size of the issue?** For this factor, ratings were based on the percentage of the community who are impacted by the identified need. The following scale was utilized: >25% of the community= 5; >15% and <25%=4; >10% and <15%=3; >5% and <10%=2 and <5%=1.
- 2) **What are the consequences of not addressing this problem?** Identified health needs which have a high death rate or have a high impact on chronic diseases received a higher rating.
- 3) **The impact of the problem on vulnerable populations.** Needs identified which pertained to vulnerable populations were rated for this factor.
- 4) **How important the problem is to the community.** Needs identified through community interviews and/or focus groups were rated for this factor.
- 5) **Prevalence of common themes.** The rating for this factor was determined by how many sources of data (leading causes of death, health outcomes and factors and primary data) identified the need.

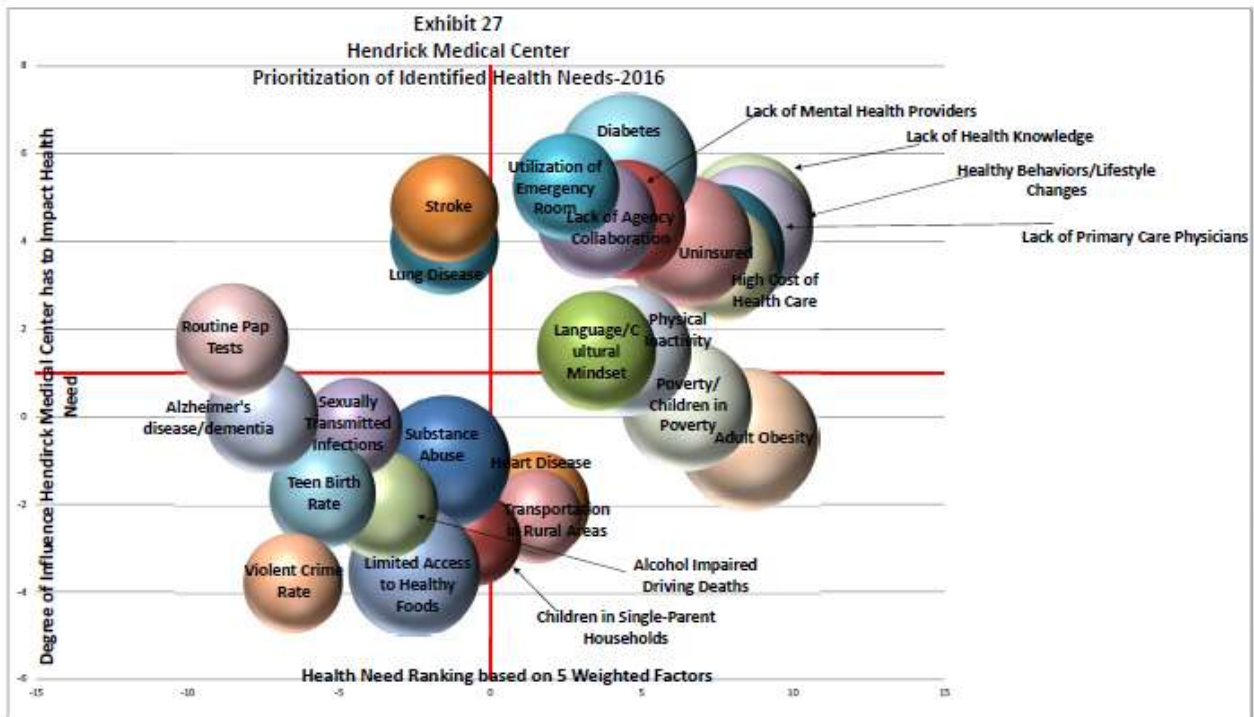
Each need was ranked based on the five prioritization metrics. As a result, the following summary list of needs was identified:

Health needs were then charted on the graph below taking into account their ranking on factors 1 through 5 (perceived importance of the need) for the horizontal axis and their ranking regarding 1) alignment with the Hospital’s strategic plans, 2) existing hospital programs that respond to the identified need; and 3) the potential opportunities to collaborate with other organizations at local/state level including available grant funding as the vertical axis. Each need was also assigned a rating between 1 and 14 regarding the health needs’ impact on overall health. Those health needs receiving the highest rating are represented by the largest sphere



Management’s Prioritization Process

For the health needs prioritization process, the Hospital engaged a hospital leadership team to review the most significant health needs reported the prior CHNA, as well as in *Exhibits 26 and 27*, using the following criteria:

- ✓ Current area of hospital focus
- ✓ Established relationships with community partners to address the health need
- ✓ Organizational capacity and existing infrastructure to address the health need

Based on the criteria outlined above, the leadership team ranked each of the health needs. As a result of the priority setting process, the identified priority areas that will be addressed through the Hospital’s Implementation Strategy for fiscal years 2017-2019 will be:

The Hospital's next steps include developing an implementation strategy to address these priority areas.

Resources Available to Address Significant Health Needs

Health Care Resources

The availability of health care resources is a critical component to the health of a county’s residents and a measure of the soundness of the area’s health care delivery system. An adequate number of health care facilities and health care providers are vital for sustaining a community’s health status. Fewer health care facilities and health care providers can impact the timely delivery of services. A limited supply of health resources, especially providers, results in the limited capacity of the health care delivery system to absorb charity and indigent care as there are fewer providers upon which to distribute the burden of indigent care.

Hospitals

The Medical Center has 522 acute beds. Residents of the community can also take advantage of services provided by hospitals in neighboring counties, as well as services offered by other facilities and providers. *Exhibit 27* summarizes hospitals available to the residents of CHNA Community.

Health Departments

The Medical Center’s CHNA community has one county health department located within it: City of Abilene Taylor County Health Department.

The Health Services Department is responsible for public health issues ranging from water testing to immunizations. Additionally, the department provides various testing and screening including, but not limited to: Blood pressure, Dental, Pregnancy, TB and STD.

The Health Department also has a Women, Infants, and Children (WIC) program. It is a supplemental food program for women, infants, and children, an important resource in improving the health and nutrition of women, infants and children during pregnancy and early childhood.

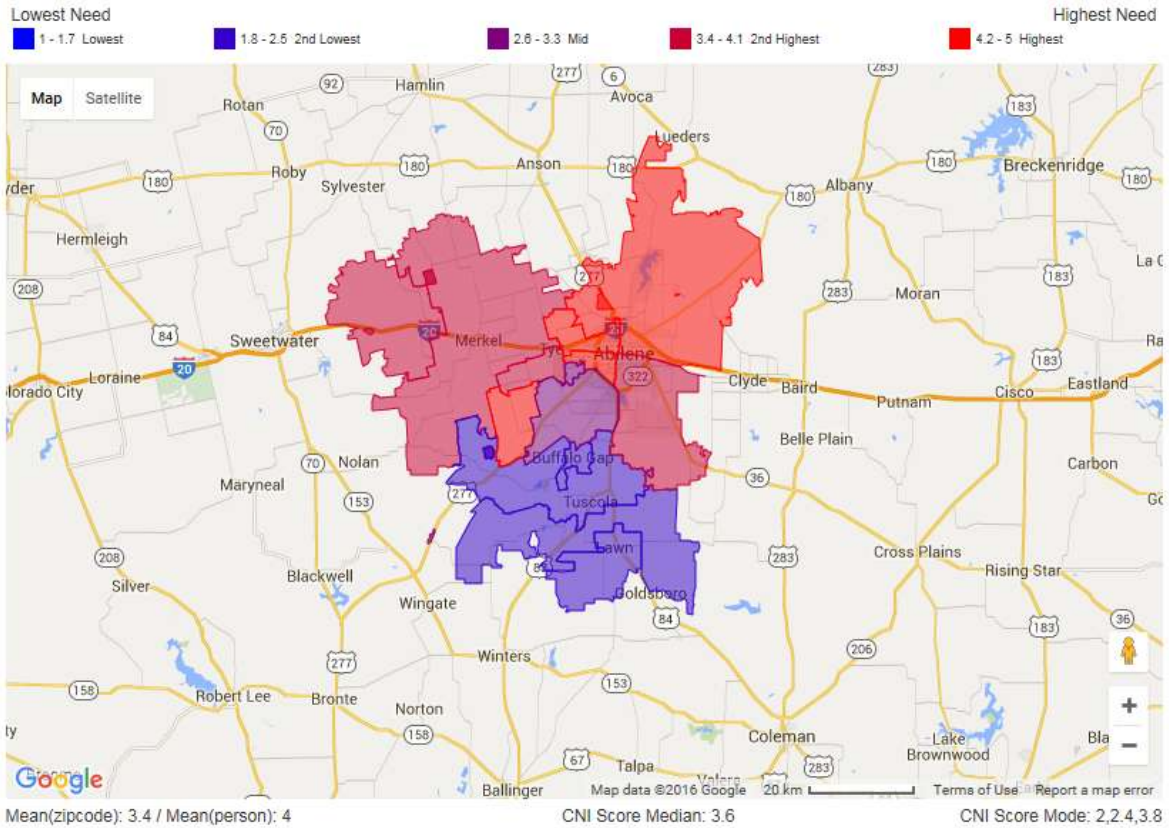
